Superintendent Suther was invited into the session.

The Board returned to open session at 7:35 pm.

Deb Hammond, CMS Art Teacher, brought along several of her students to show the Board several types of art projects they have been working on this year. Each student presented several projects and explained them in great detail.

From the 6^{th} grade, there was Echo Bell, Lane Combs and Deegan Leighty. From the 7^{th} grade, Hayden Riffel presented.

From the 8th grade, Tracy Gibson and Maddison Grubb presented.

We had a presentation on the MTSS (Multi-Tier System of Support) Impact in the Classroom given by Valerie Rock - CES Title Teacher, Amy Jones – ENT 1st Grade Teacher (who brought along one of her students to demonstrate Heggerty – Kyler Harwood), Robert Cox and Kate Thornton (who also brought along one of her students to talk about this year's Book Club Program at CHS – Raleigh Lusk)

Kelly Kuntz made the motion to approve the Early December Graduates that were presented to the Board, pending completion of all State Dept. and CHS requirements. Jerry Wright seconded the motion; motion carried 7-0.

Superintendent Suther let the Board know that the (2) 2022-23 calendar choices are in Dropbox for their review. The committee will have the teachers VOTE on the (2) proposals, and the decision will be brought back to the January 10th Board meeting for them to approve their choice.

Superintendent Suther went over a scope of work that he is requesting the Board give approval to TRANE to perform an indoor air quality (IAQ) and ASHRAE Service Life Assessment using ESSER III funds. The very 1st step is to sign a Letter of Intent to begin the 1st phase. TRANE will come do a Work Session to discuss possible options. The monies used in this service must be spent by 2024. This is one project earmarked for the money.

Superintendent Suther informed the Board that the December 2021 KASB Policy updates are loaded in Dropbox and ready for their review. His recommendation is to adopt them all into policy and this will be an action item at the January 10th BOE meeting.

Jerry Wright made the motion to approve all Personnel items that were presented for the Board for their review. Bob Haynes seconded the motion; motion carried 7-0. They were:
